2. Use of Personal Information

2.1. Non-Custodial Wallet:

Scurdex Capital operates a non-custodial cryptocurrency wallet. As a non-custodial service, we do not have access to or control over your private keys, wallet addresses, or any personal information associated with your wallet.

2.2. Transaction Tracking:

In order to provide support after a purchase of a crypto asset on the Ramp network through our partner, Ramp, we may track transaction information through wallet addresses. We utilize a backend webhook to log users' transactions, which are identified only by their wallet address. This information is solely used for support purposes and is not linked to any identifiable personal information.

3. Disclosure of Personal Information

3.1. Third-Party Services:

Scurdex Capital may engage third-party services, such as Ramp, to facilitate cryptocurrency transactions. Any personal information you provide or share with these third-party services is subject to their respective privacy policies and terms of service. We encourage you to review these policies before engaging in any transactions.

3.2. Legal Compliance:

We may disclose personal information if required by law, regulation, legal process, or governmental request. We may also disclose personal information to enforce our policies, respond to claims, or protect the rights, property, or safety of Scurdex Capital, our users, or others.
